Article I(O.) DRIVEWAY & CONCRETE STAINS

All driveways, sidewalks and walkways visible from the street must be of poured and troweled concrete only and must be maintained in clean condition and not in need of repair. Staining or repainting of any driveway, sidewalk or walkway visible from the street must conform in color to the established standard. The single Standard color for the staining of any visible concrete surface including driveways, walkways and sidewalks will be Natural Cement. Stained surfaces should be sealed with an appropriate, suitable product. Upon staining, all surfaces must be continuously maintained in good condition and appearance. Concrete driveway, sidewalks and walkways currently in a non-complying color may not be repainted or re-stained except in the approved standard color herein designated. The Association may reasonably require worn, non-compliant colored surfaces in poor condition to be re-stained in the herein standard color.
