President's Message

Dear Bayport West Homeowners,

The Board of Directors is pleased to introduce quarterly neighborhood beautification initiatives.

Although we have been informally enforcing some aspects of our deed restrictions, the Board has elected to schedule certain areas to focus on over the next 12 months. The response from many homeowners has been positive; they feel that it keeps their major maintenance issues "front of mind" and also appreciate the reminder that certain areas need attention especially during different times of the year. For example, the need for pressure washing after the rainy season.

The tentative schedule for 2025-2026 is as follows:

Summer - Trim and Gable Color

Fall - Pressure Washing

Winter - Garage Doors, Clean and/or Paint Brick Reveal, House Color

Spring - Trimming Trees and Shrubs

Please see below for the information regarding trim color enforcement. Flyers were distributed in May to inform homeowner's and allow 45 days notice of the potential for violation.

Overall, we should be very proud of the care and attention the homeowners of BPW give to make our neighborhood beautiful.

TRIM COLOR ENFORCEMENT

As noted in the flyer that was distributed in May, the HOA will be begin issuing violations regarding faded or incorrect trim color effective August I, 2025. If your trim work has faded, is sun bleached to a reddish color, or is not painted the approved color of **Bayport West Dark**, then it is in need of repainting.

The approved color, **Bayport West Dark**, is available at Sherwin Williams, The Home Depot, and Lowe's. All approved paint colors are referenced on the bulletin board and available on our website (https://bayportwesthoa.org/documents.php).

Hillsborough County repaired 53 uneven areas in our community. The County performed the repairs by grinding the concrete sections down which was their recommendation for sidewalk panels that are raised less than 2 inches.

Many thanks to Claire & David Matthews for their hard work in walking the neighborhood and inspecting the damaged sidewalks, and to Roger Verszyla for reporting, coordinating and following up with the County to ensure the sections were repaired.

What YOU Can Do!

Everybody is subjected to snipe signs and their obnoxious roadside pleas.

Those who post them in public right-of-ways are breaking the law, according to Hillsborough County Code Enforcement.

The illegal signs are not just unsightly, they can be hazardous.

How You Can Help

Volunteers in Public Service is a group of concerned residents who work with Code Enforcement to remove illegal snipe signs. VIPS program volunteers get a background check and training so they understand the dangers posed by the signs. For more information about the VIPS program, visit HCFLGov.net/CODE or call (813) 274-6600.

What you should know about snipe signs:



- In Hillsborough County, signs in the right-of-ways are illegal unless permitted by the Hillsborough County Board of County Commissioners and can be removed
- Permitted signs are regulated and provide direction to specific events in the County that draw large numbers of people
- · Snipe signs deteriorate and become litter
- Snipe signs can dislodge and endanger pedestrians and damage vehicles during severe weather

The County's Land Development Code:

- A snipe sign is any sign attached in any way to a utility pole, tree, fence post, or any other object located on public or private property
- Any sign designed to provide warning to the public shall not be construed to be a snipe sign
- Section 7.04.01 of the Hillsborough County Land Development Code –
 Signs on Right-of-Way, prohibits signs from being placed on County property
- No sign shall be erected on the public right-of-way and publically dedicated
 easements except signs installed by governmental units having jurisdiction
 as may be required by law or to protect the public health, safety and welfare,
 bench signs, and signs authorized to be placed on transit shelters
- Any other sign located upon, within or otherwise encroaching upon the public right-of-way of Hillsborough County shall be subject to immediate removal by the County at the expense of the owner, agent, lessee or other person determined to have beneficial use of the sign

VIOLATIONS COMMITTEE REPORT PARKING VIOLATIONS

During the past few months, I have been approached by many homeowners voicing their concerns about the vehicles blocking the sidewalks. This becomes a major safety issue to our neighbors who are out walking, pushing strollers, using walkers, and/or accompanying small children on bikes. They must cross into the street to bypass a blocked driveway.

The Bayport West By-laws prohibit the blocking of the sidewalks.

Page 9 of 12 "Rules and Regulations" - Item C. Storage:

Parking on any area of grass or on any lawn is prohibited, all vehicles must be parked entirely upon the driveway of an owner's lot or within the garage of a particular unit. Parking on any driveway of any lot must be in such a manner so as not to block, either or completely or partially, any sidewalk.

MESSAGE FROM THE PRESIDENT

Our garages and driveways can each accommodate two vehicles or four vehicles total. When parked in front of the garage door there should be ample clearance behind the vehicles so that they do NOT block the sidewalks. If the homeowner cannot park in a manner that adheres to the above noted by-laws, please park on the street in the direction of traffic with the wheels in the gutter. Please do not park on the grass or perpendicular to the driveway (such as between the mailbox and light pole). Also, please be mindful when parking on the street to avoid parking directly across from another vehicle. There are large trucks and service vehicles that need enough clearance to navigate safely on our roads. We just ask that you be mindful of our deed restrictions and courteous to others when parking. Thank you.

HOW TO REPORT / REPLACE A DAMAGED GARBAGE OR RECYCLING CART

HOW TO REPORT DAMAGE:

- 1. Report your damaged cart by email solidwaste@hcfl.gov or by visiting the website: https://hcfl.gov/residents/property-owners-and-renters/trash-and-recycling/report-a-broken-trash-or-recycling-cart
- 2. The order will be completed within three business days of the initial date of request
- 3. Keep the broken roll-cart curbside until Solid Waste completes the cart repair/ replacement
- 4. Tape your email confirmation to your cart

Failure to place your cart at the curb during the repair/replace time-frame may result in delays or cancellation of your request.

WHAT TO EXPECT: Once you submit the damage request, you will receive an email confirmation that your request has been received. When your roll-cart has been repaired / replaced you will receive an email notification that your request has been closed. If you report by telephone, you will not receive an email confirmation.

In an effort to protect each individual's rights and home values, any homeowner or group of homeowners considering improvement to their property must submit a *Request for Home Improvement* form to the Architectural Control Committee if such work affects the structure or appearance of a building and/or is visible from the street. This approval must be obtained <u>PRIOR</u> to initiating the work. Any and all subsequent changes to this project must also be approved or this document becomes null and void and the homeowner may be required to return the property to its original condition.
